**Vaccine Mandate** Some Military Contractors and bases are mandating vaccination following the presidential Executive Order dated September 9th and updated (8/13) OSHA guidance for mitigating and preventing the spread of COVID-19 in all industries. Currently LM Space in Sunnyvale is **NOT** requiring the employees on site nor their contractors to be vaccinated– we spoke to the company about this, and they clearly understand that if the customer were to require this that we would need to enter into “effects bargaining”. I will keep you apprised if anything changes.

**Certification of Vaccination Form** – Some areas such as B/181/182 which are closely aligned with the US are requiring employees to fill out forms inquiring the same information as the vaccination tool. It is possible that the DCMA may audit so have them on your person.

**Gate Signage** As you may have noticed driving in, there are Covid signs at the gates, they currently indicate a High-Risk Level, and that Facial Coverings are required. Please follow all CDC requirements regarding Covid prevention guidelines.

**The Business Resiliency COVID-19 Response Team** is tracking the new presidential Executive Order and how it may impact the Company. This is not a military base, but Lockheed Martin is a Federal Contractor. It is the company’s intent to continue to follow CDC guidelines. The Executive Leadership Team is still reviewing the new announcement. When we receive information from the company, we will share it with you.
