Mandated Vaccinations & Effects Bargaining – Today the Union and the Company met to discuss the effects and bargain over the change in working conditions due to the Vaccination Mandate that requires all employees to be fully vaccinated by December 8th, 2021. Accommodations for religious and medical reasons are allowed if certified by the company. The Union submitted a proposal to the Company, and we are awaiting their response. Our proposal was extensive as we search for ways to soften the impact of this mandate on the membership. The Company may respond as early as tomorrow afternoon. We will keep you apprised.

You must certify your vaccination status in the enhanced COVID-19 Vaccination tool by Oct. 21. Medical or religious accommodations must be submitted by Oct. 21. That link can be found on LMPeople

<u>Certification of Vaccination Form</u> – The NIROP buildings in Sunnyvale and the SCTB, which are DOD facilities require employees to fill out the DD-315 form which contains similar information as the LM vaccination tool. It is possible that the DCMA may audit employees working or entering these facilities, so have them on your person or readily available in the event you are asked.

Mask wearing tips:

"Following recent <u>Lockheed Martin</u> and CDC guideline updates, the Bay Area facilities are in an area with a <u>substantial or high COVID-19 transmission rate</u>. All personnel in the Bay Area, regardless of vaccination status, are required to wear a mask while onsite.
