<u>Memorandum of Agreement Rejected</u> - Last week, Union members voted to reject the company's MOA for proposed Vaccination Mandate Workplace Changes. The Union Negotiating Committee needs your feedback in order to carry on further dialogue with the company in order to address the membership's concerns with the existing proposal. <u>Your input is important</u>, <u>so please contact your Union representatives as soon as possible</u>.

<u>More Courts enjoin in the stay of the mandate</u> - A federal judge issued a nationwide injunction against the vaccine mandate for federal contractors, ruling that President Joe Biden probably exceeded his authority by imposing the requirement, since then more courts have enjoined in this action against the Executive orders, we will keep you informed as this proceeds though the judicial system.

KNDS Policy for 2022

The Company has confirmed that COVID vaccinations and booster shots, may be covered by KNDS. Should an employee not be able to flex their work time or schedule their vaccination during non-scheduled work time to obtain the vaccine, the Company will pay up to two (2) paid non-work hours per dose. In addition, employees who are experiencing side effects from receiving the COVID-19 vaccine will be eligible to use KNDS for up to two (2) consecutive days immediately following vaccination, provided they notify management for each day they are not at work due to related side effects.

Mask wearing tips:

Following recent <u>Lockheed Martin</u> and CDC guideline updates, the Bay Area facilities are in an area with a <u>substantial or high COVID-19 transmission rate</u>. All personnel in the Bay Area, regardless of vaccination status, are required to wear a mask while onsite.

Employee Vaccination Status

Numbers as requested and received from the company:

<u> Sunnyvale / Palo Alto –</u>


- 320 employees are certified as fully vaccinated,
- 1 employee Fully Certified but not yet submitted Card through the LM tool
- 23 employees granted accommodation
- 1 employee has submitted accommodation requests: pending approval

- 4 employees are in process of being vaccinated (but not fully vaccinated),
- 3 employees have done nothing at all
 - 2 employees have certified that they are not vaccinated using the old online tool and have not responded to the Company.

Santa Cruz Facility

- 38 employees are fully vaccinated
- 4 employees granted accommodations

Based on these numbers, 6 employees are still at risk of job loss, when the enforcement date arrives; of course, as of this Report the previous enforcement date is being blocked by the Courts, as things change, we will pass it on.



Home Quarantine Steps:

What should I do if I find out that I've been in close contact with a case? The applicable quarantine rules depend on whether you are fully vaccinated. You are considered fully vaccinated if you have received, at least 14 days prior, either the second dose in a two-dose COVID-19 vaccine series or a single-dose COVID-19 vaccine.

Note: The vaccine must have been FDA-approved or authorized for emergency use by the <u>FDA</u> (e.g., Pfizer, Moderna, Johnson & Johnson) or the <u>World Health Organization</u> (e.g., AstraZeneca/Oxford, Covishield, Sinopharm, Sinovac).

When quarantine is NOT required:

Fully vaccinated individuals are not required to quarantine after being exposed to a case if they meet <u>ALL</u> the following criteria:

- Are fully vaccinated.
- Have not had any <u>COVID-19 symptoms</u> since the COVID-19 exposure.
- Are not an inpatient or resident in a healthcare setting or facility.

Fully vaccinated individuals should get tested **immediately** and on **day 5** after exposure (if identified as a close contact to a confirmed case of COVID-19), monitor themselves for symptoms for 10 days after exposure. <u>Certification of Vaccination Form</u> – The NIROP buildings in Sunnyvale and the SCTB, which are DOD facilities require employees to fill out the DD-3150 form which contains similar information as the LM vaccination tool. It is possible that the DCMA may audit employees working or entering these facilities, so have them on your person or readily available in the event you are asked.
